## Bylaw Changes proposed November 2019

- 1. Date on cover page
- 2. General Formatting to capture and correct errors in lettering and numbering
- 3. Article III Membership > Section 3.04 > Addition of Thunder Board Representative
  - 4. Each booster club shall have an elected Thunder Board Representative as part of their Executive Board acting as the liaison between the Thunder Board and their respective Booster Club. If a club is unable to fill the role another officer of the Club's Executive Board may serve as the Club's Thunder Board Representative for the duration of the school year, or until a special election can be held to fill the position. The Thunder Board Representative will:
    - (a) Represent the corresponding Booster Club at the Thunder Board All Clubs monthly meetings.
    - (b) Keep the corresponding Booster Club informed of policies, procedures, and rules of the Thunder Board.
    - (c) Keep the Thunder Board informed of corresponding Club's officers, officer's contact information, events, activities, finances, meetings, and proposed fundraising events.
    - (d) Relay Thunder Board minutes to corresponding Booster Club.
    - (e) Take notes at all Thunder Board All Clubs meetings and communicate in a timely manner these notes with the corresponding Booster Club's Executive Officers.
    - (f) Attend all Thunder Board All Clubs monthly meetings.
- 5. Article IV Thunder Board Officers, Election and Terms in Office >
  - a. Section 4.01
    - i. Add Treasurer Elect
  - b. Section 4.05 (b)
    - i. Corrected lettering/numbering in order of preference for Absence of President listing President-Elect as First in order
- 6. Article V > Thunder Board Officers and Their Duties
  - a. Section 5.01 (c)
    - i. Removed "Be a signatory on the bank account and regularly monitor banking activity
  - b. Section 5.05
    - i. Corrected the name of the Communication Secretary
  - c. Section 5.07 Addition of the Treasurer-Elect. "The Treasurer-Elect will"
    - i. Act for the Treasurer in the absence of the Treasurer.
    - ii. Succeed to the office of Treasurer for the following fiscal year, which effectively makes the office of Treasurer-Elect a 2-year commitment.
    - iii. Succeed immediately to the office of Treasurer in the case of a permanent vacancy.
    - iv. Perform such other duties as assigned by the Thunder Board and its Officers."
  - 7. Article VII Meetings
    - a. Section 7.01 Membership Meetings addition of December & May verbiage
      - Regular meetings of the Thunder Board will be held at a minimum of once per month during the school year. The date, time, and location will be determined by a majority vote. Exceptions are December & May if the Executive Board determines those meetings are not necessary.
- 8. Article X Finances
  - a. Section 10.01 removed the President as a signatory on the bank account
  - b. Section 10.01 addition of verbiage for special circumstances, "(a) In situations where a Booster
    Club does not have a Vice President the President may be a signatory on the bank account.
